

Terms and Conditions for Batam Fast Travel Insurance Lite (BFTL) June 2024 Desaru Coast and Tanjung Pengelih Promotion:

1. Eligibility

- 1.1 The BFTL June 2024 Desaru Coast and Tanjung Pengelih Promotion is organized and administered by Batam Fast Ferry Pte Ltd. The Validity of the promotion period is from 1 June 2024 until 30 June 2024, both dates inclusive.
- 1.2 This Promotion is only open to Singapore residents aged 21 and above who purchased the Batam Fast Travel Insurance Lite policy for their trip to Desaru Coast or Tanjung Pengelih during the stated promotion period (“Qualified Policyholder”).
- 1.3 This Promotion is only for bookings with a minimum of three (3) policyholders per booking (“Qualified booking”).
- 1.4 Each qualified policyholder in the qualified booking will have one chance to win the prizes indicated below.
- 1.5 Winners will be randomly selected. Each qualified policyholder in the qualified bookings can only win one (1) Prize.

2. Conduct of Draw, Notification, and Redemption of Prize.

Winners must redeem their Prize by presenting the email notification sent by Batam Fast Ferry Pte Ltd to the counter staff at the Batam Fast outlet located at Harbourfront Centre during operation hours (Daily, from 0700hrs to 2100hrs) by 8 August 2024.
- 2.4 Batam Fast shall not be liable for any failure or unsuccessful delivery of the prize redemption notification to any of the Winners. There will be no resending of the email notifications after the indicated date.
- 2.5 Any unclaimed or uncollected prizes will be retained by Batam Fast and will deal with the said items as they deem fit.

2.6 All prizes are not transferable or exchangeable for cash, credit, or kind. Batam Fast reserves the right to replace the Prizes with other items of similar value at its discretion.

### 3. General Conditions

3.2 Batam Fast reserves the right to disqualify any person from participating in this promotion for any reason whatsoever; or disqualify any person from receiving any prize from this promotion for any reason whatsoever.

3.3 Without prejudice to the generality of clause 3.2 above, non-compliance with these T&Cs and/or the breach of any other requirements communicated by Batam Fast to the qualified policyholder may, at Batam Fast's sole discretion, result in the immediate disqualification of the said person from participating in this promotion.

3.4 Batam Fast reserves the right to extend or terminate the promotion or vary, delete, or add to any of these T&Cs from time to time without notice, and at its sole absolute discretion.
