

TRAVEL REQUIREMENTS SINGAPORE – BATAM

Based on Surat Edaran SATGAS COVID-19 No. 13 2022

WHAT YOU NEED

- 1 Vaccinated minimum 2 doses*, at least 14 days before date of departure. Vaccinated exemption** for Travelers under 18 y.o traveling with fully vaccinated adults.
- 2 Pre-departure negative RT-PCR result with sample taken maximum 2x24 hours before departure.
- 3 On-Arrival RT-PCR test. Travelers have to self-isolate while waiting for results, and are free to resume itinerary activities* at Batam after receiving the negative result.
- 4 RT-PCR test on day-3 after arrival*. Travelers are allowed to leave Batam area after testing negative.
- 5 Download Peduli Lindungi apps. Fill up e-HAC through Peduli Lindungi apps. Utilize Peduli Lindungi apps for activities in Batam.

* Travelers not completed second dose vaccine are required to quarantine for 7x24 hours, and do exit PCR at day 6.

Nongsa Point Marina & Resort 3. Turi Beach Resort 4. Montigo Resort Required to self isolate at approved leisure hotel or resort while waiting for on-arrival RT-PCR test result. Required to show valid entry visa for Non Singapore Citizens, Non Singapore Permanent Resident, and Singapore Permanent Resident whose nationality is <u>not</u> listed within the 25 countries***. Free visa or VOA travelers are required to show a return ticket or one-way ticket to continue traveling to another country***.
