

# TRAVEL REQUIREMENTS SINGAPORE – BATAM

Based on Surat Edaran SATGAS COVID-19 No. 15 2022

## WHAT YOU NEED

- 1 Vaccinated minimum 2 doses[1], at least 14 days before date of departure. Vaccinated exemption for Travelers under 18 y.o traveling with fully vaccinated adults[2].
- 2 Pre-departure negative RT-PCR result with sample taken at origin country (Singapore) maximum 2x24 hours before departure.
- 3 On-Arrival RT-PCR test. Travelers have to wait for a negative RT-PCR result at hotel room or place of accommodation before resuming activities. Travelers may wait for PCR result at eligible locations. Refer to Table 1.
- 4 Download Peduli Lindungi apps. Fill up e-HAC through Peduli Lindungi apps. Utilize Peduli Lindungi apps for activities in Batam.

Table 1. On-Arrival RT-PCR Result Waiting Location

Location	Requirements
Home or Place of Accommodation	Batam domicile travelers are required to show Batam KTP, Domicile Letter (Surat Keterangan Berdomisili), or KITAS/KITAP/SKTT (Surat Keterangan Tempat Tinggal) with stated address in Batam.
Hotel	Non-Batam domicile travelers are Required to show hotel booking confirmation at Batam and payment. Required to be picked up from terminal by hotel.

## ADDITIONAL MEASURES FOR NON-INDONESIAN CITIZENS (WNA)

- 5 Non-Indonesian Citizen (WNA) PPLN are required to have health insurance with COVID-19 treatment and evacuation coverage of minimum SGD \$20,000.
- 6 Required to show valid Entry Visa for Non Singapore Citizens, Non Singapore Permanent Resident, and Singapore Permanent Resident whose nationality is NOT listed within the 25 countries[3] listed below.

## FREE VISA & VOA REQUIREMENTS TO BATAM

- 1 Free visa or VOA travelers are required to show a return ticket or one-way ticket to continue traveling to another country[3].
- 2 Required to show accommodation confirmation evidence.
- 3 Singapore Citizens & Singapore Permanent Resident (PR) whose nationality is any of 9 countries listed below may enter Batam with 14 days free visa; not extendable[3]:
- 4 Singapore Citizens & Singapore Permanent Resident (PR) whose nationality is any of 25 countries listed below can get Leisure VOA for 30 days, VOA fee IDR 500,000; extendable 1 time[3]:
