

TRAVEL REQUIREMENTS SINGAPORE – BATAM

Based on Surat Edaran SATGAS COVID-19 No. 17 2022

WHAT YOU NEED

- Vaccinated minimum 2 doses**[1], at least 14 days before date of departure. Vaccinated exemption for Travelers under 18 y.o traveling with fully vaccinated adults[2].
- Pre-departure negative RT-PCR** result with sample taken at origin country (Singapore), maximum 2x24 hours before departure.
- Download **Peduli Lindungi** apps. Fill up **e-HAC** through Peduli Lindungi apps. Utilize Peduli Lindungi apps for activities in Batam.
- On-arrival RT-PCR test **required only** for:
 - Travelers arriving with COVID-19 symptoms and/or body temperature above 37.5 degree Celsius.
 - Non-fully vaccinated travelers.
 - Recovered travelers (see below).

Travelers have to wait for a negative RT-PCR result at hotel room (picked up from terminal by hotel) or place of residence (show KTP Batam/Surat Domisili/SKTT) before resuming activities.

ADDITIONAL MEASURES FOR NON-INDONESIAN CITIZENS (WNA)

- Non-Indonesian Citizen (WNA) PPLN are required to have **health insurance** with COVID-19 treatment and evacuation coverage of minimum SGD \$20,000.
- Required to show valid Entry Visa for travelers whose nationality is **not** eligible for free visa or visa on arrival (VOA).

FREE VISA & VOA REQUIREMENTS TO BATAM

- Free visa or VOA travelers are required to **show a return ticket** or one-way ticket to continue traveling to another country[3].
- Travelers whose nationality are from countries listed below may enter Batam with **30 days free leisure visa**; not extendable[3]:

- Travelers whose nationality are from countries listed below can get **Leisure visa on arrival (VOA) for 30 days**, VOA fee IDR 500,000; extendable 1 time[3]:

RECOVERED TRAVELER

Travelers that have ever tested positive COVID-19 maximum 30 days before departure and declared no longer infectious, are exempted from showing vaccination proof requirement and negative pre-departure RT-PCR test result. Recovered Travelers are required to show **recovery certificate from Government Hospital**.

However, Recovered Travelers are still subject to **On-arrival RT-PCR test**, and if tested **Positive** will be **subject to isolation** at isolation hotel/facility. Recovered Travelers are still subject to **5x24 hours quarantine** if **not fully vaccinated**.

[1] Travelers not completed second dose vaccine are required to quarantine at quarantine hotel* for 5x24 hours, and do exit PCR at day 4.

[2] Quarantine requirement to follow with accompanying parents/guardians.
