## TRAVEL REQUIREMENTS Batam – Singapore

**VACCINATION TRAVEL FRAMEWORK** 

**STARTING APRIL 1, 2022** 

## WHAT YOU NEED



Fully vaccinated[1], and produce either a Digital Vaccination Certificate (DVC) or non-DVC issued in any country classified under General Travel or Singapore that is recognized by the Singapore authorities.

Children aged 12 years and below in the calendar year are not required to be fully vaccinated[2].

Negative pre-departure test (PDT)[3] within 2 days[4] before departing for Singapore. PDT can be:

- 1.Polymerase Chain Reaction test (PCR test) at an internationally accredited or recognized lab, clinic, medical facility.
- 2. Professionally administered Antigen Rapid Test (ART)[5].

Children aged 2 and below in the calendar year are not required to undergo PDT[6].



All travelers must submit <u>SG Arrival Card</u> health and travel history declaration up to 3 days before arriving in Singapore.

All travellers entering Singapore must comply with the prevailing health protocols and use the TraceTogether app in Singapore to facilitate contact tracing in Singapore.



Travelers must not have been in any Restricted Category within the last 7 days.



Short Term Visitors only:

Purchase travel insurance, with a minimum coverage of SGD \$30,000 for COVID-19 related medical treatment prior to travel.

Non fully vaccinated travelers are subject to Letter of Entry. Other requirements for non fully vaccinated travelers please refer to <u>SafeTravel website</u>.

Provide entry visa if required. <u>Click here to check if entry</u> visa is required.



Non fully vaccinated travelers will continue to be subject to the prevailing COVID-related protocols, including testing requirements and SHN. More details are available on the <u>SafeTravel website</u>.

Fully Vaccinated & Recovered Traveler may refer different entry requirements. More details are available on the <u>SafeTravel website</u>.

Non-Malaysian Work Permit In-principle Approval holders employed in the Construction, Marine shipyard and Process Sector (CMP worker) are required to <u>apply for</u> <u>entry approval from Ministry of Manpower</u>.

[1] An individual is considered fully vaccinated 14 days after he/she has received the full regimen of any World Health Organisation Emergency Use Listing vaccines.

- [2] To illustrate, children born in or after 2010 entering Singapore under the Vaccinated Travel Framework in 2022 are not required to be fully vaccinated.
- [3] Non-handwritten PDT report that is in English (or accompanied by a notarised English Translation) with the following details: Traveller's name, and Date of Birth or Passport number. Reflects the date and result of the COVID-19 test.
- [4] To illustrate, if the pre-departure test is taken on 1 April 2022, it will be valid up to 3 April 2022, 2359 hours.
- [5] The ART must be performed by trained professionals such as medical professionals and Government-recognized trained professionals.
- [6] To illustrate, children born in or after 2020 entering Singapore under the Vaccinated Travel Framework in 2022 are not required to undergo the pre-departure test.

## TRAVELING/RETURNING TO BATAM

Travelers traveling/returning to Batam are subject to entry regulation based on the latest Circular.
